SECURITY DEPOSIT

A refundable security deposit of **\$200.00** will be charged at the time of registration. A refundable security deposit of **\$500.00** will be charged for tournaments. Deposits shall be returned approximately 2 weeks after the date of the rental if area was left in an orderly state. Additional fees will be added and paid for by renter if any damage occurs from the misuse of the facility and its property. Rental permit shall be revoked at any time due to misconduct of individuals, falsification of information, misuse of property, unlicensed consumption of alcohol, or failure to comply with Park District rules and regulations. Rental deposit will be forfeited to the Park District and future permits will not be issued to groups of individuals involved.

INDEMNIFICATION AND HOLD HARMLESS

Lessee agrees to protect, indemnify, save, defend and hold harmless the Park District, its officers, officials, volunteers, employees, and agents (hereafter collectively referred to as "District") from and against any and all liabilities, claims for compensation, obligations, claims, damages, penalties, by any reason of accident, injury or death of persons or loss of or damage to property, arising indirectly or directly in connection with or under, as a result of this agreement, whether such themselves or any equipment thereon whether latent or patent, or from other causes whatsoever, except for claims, damages, penalties, causes of action, costs and expenses, arising solely by virtue of any negligent act or omissions of the District.
